- 1 A BILL for an Act to amend and reenact sections 54-66-01 and 54-66-06 of the North Dakota
- 2 Century Code, relating to the definitions and notice to an accused individual.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 54-66-01 of the North Dakota Century Code is
- 5 amended and reenacted as follows:
- 6 **54-66-01. Definitions.**
- As used in this chapter, unless the context otherwise requires:
- 8 1. "Accused individual" means a lobbyist, public official, candidate for public office,
- 9 political committee, or contributor who is alleged to have violated article XIV of the
- 10 Constitution of North Dakota, this chapter, or another law or rule regarding
- transparency, corruption, elections, or lobbying.
- 12 2. "Complainant" means a North Dakota residentan individual who, in writing or verbally,
- submits a complaint to the commission and is:
- 14 <u>a. A North Dakota resident;</u>
- b. Subject to licensing or regulation by a state agency or other public official subject
- 16 <u>to the jurisdiction of the ethics commission; or</u>
- 17 c. Is a party to a quasi-judicial proceeding before a state agency or other public
- official subject to the jurisdiction of the ethics commission.
- 19 3. "Complaint" means a verbal or written allegation to the commission that a lobbyist,
- public official, candidate for public office, political committee, or contributor has
- violated article XIV of the Constitution of North Dakota, this chapter, or another law or
- rule regarding transparency, corruption, elections, or lobbying.
- 4. "Ethics commission" or "commission" means the North Dakota ethics commission
- established by article XIV of the Constitution of North Dakota.

An elected or appointed official of the state's executive or legislative branch. 15 members: 16 <u>b.</u> <u>Members</u> of the <u>ethics</u> commission, members; 17 <u>c.</u> <u>Members</u> of the governor's cabinet, and employees: 18 d. Employees of the legislative branch; and 19 e. Directors, officers, commissioners, heads, or other executives of state agencies. 20 10. "Receives the complaint" means one or more members of the commission learn of the 21 complaint. 22 11. "Ultimate and true source" means the person that knowingly contributed over two 23 hundred dollars solely to lobby or influence state government action. 24 SECTION 2. AMENDMENT. Section 54-66-06 of the North Dakota Century Code is 25 amended and reenacted as follows: 26 54-66-06. Subject to the confidentiality requirements set forth in section 30 54-66-05, the accused individual will be provided with the written complaint or written 31 summary of the oral complaint, witness statements, and other documentary evidence

1		considered as soon as reasonably possible but no later than twenty calendar days
2		after the commission receives included with the complaint. The accused individual may
3		respondprovide a written response to the complaint in writing within twentythirty
4		calendar days of receipt of, or after the commission requests a written response to the
5		complaint or summary of the complaint, a period as set by the commission. This
6		subsection does not preclude the accused individual from providing a written response
7		to the complaint before receiving a request for written response from the commission.
8	<u>2.</u>	If the commission has summarily dismissed the complaint under subsection 2 of
9		section 54-66-05, before notifying the accused individual as required by this section,
10		the notification to the accused individual must include notice of the summary
11		dismissal.
