Engrossed HB 1210 is related to the qualification and notification requirements for sales and use tax exemptions for certain sales made to a senior citizen organization.

Section 1 and section 2 of engrossed HB 1210 expands the sales and use tax exemption for sales to a senior citizen organization that provides informational, health, welfare, counseling, and referral services for senior citizens in this state.

In order for the sales to be exempt, the senior citizen organization must; be recognized by the IRS as having exempt

status under 26 U.S.C.501(c)(3), be recognized by the secretary of state as a charitable organization, and either provide services through the aging services division of the Department of Health and Human Services, receive grant funds through the Department of Transportation which are used for enhanced mobility of seniors and individuals with disabilities, or provide services through a contract with the department of health and human services as a program of all-inclusive care for the elderly.

If enacted, engrossed HB 1210 may reduce state general fund and state aid distribution fund revenues in the 2023-2025 biennium.

The reduction in revenue is dependent upon the purchase amounts made for a qualifying exempt senior citizen organization. Since the future purchase amounts made for a qualifying exempt senior citizen organization cannot be quantified, the Office of State Tax Commissioner is not able to provide an estimated fiscal impact.
