Bill impacts OMB, Atty Gen, all state agencies & HE intuitions purchasing goods, services, IT and printing with fiscal impacts to OMB/NDUS/Atty Gen to develop rules, guidelines, templates, training and impacts to all state agencies/institutions to implement.

The bill impacts all procurement of goods, services, IT and printing which is difficult to measure. OMB/NDUS/Atty Gen fiscal impact assumes rules, guidelines, templates, training developed with existing staff and no additional appropriation. Time required by state agencies and institutions to implement the bill is difficult to measure given the broad language "may give priority" and unknown effort to determine which companies "support the state's

agriculture and energy industries." Impact to companies desiring to compete for state contracts difficult to determine. Difficult to determine any fiscal impact on the state's agriculture and energy industries if this bill is enacted.
