HB 1408 as amended exempts 10% of land enrolled in private land open to sportsmen from taxation.

**4 - Fiscal Impact Sections Detail**

Over 800,000 acres of land are enrolled in the private land open to sportsmen program in North Dakota. For this fiscal note, a \$2,000 value per acre was used to calculate this fiscal note. The Department of Public Instruction could not get the actual valuation of the land enrolled in this program. The state uses a 60-mill contribution of taxable valuation to calculate the state aid portion of the Integrated Formula payments. Decreasing the taxable valuation will increase state aid being distributed to school districts. The department estimates a cost of \$960,000 per year but the amount could increase as more landowners enroll in the program with this tax incentive.
