Engrossed SB2276 creates a new section to chapter 50-06 related to the appointment and duties of the cross-disability advisory council, the need for a facilitator, and allowance of members of the council to receive reimbursement for travel and lodging at the same rate as provided to state employees.

Section 1 of Engrossed SB 2276 creates and enacts a new section to chapter 50-06 related to the appointment and duties of the cross-disability advisory council, the need for a facilitator, and allowance of members of the council to receive reimbursement for travel and lodging at the same rate as provided to state employees.

The projected cost for the 2023-2025 biennium for the travel and lodging reimbursement for fifteen council members and council facilitator costs is \$38,820 in general funds and \$38,820 in federal funds.

Section 1 of Engrossed SB2276 requires the Department of Health and Human Services to contract with a third-party vendor to act as a facilitator to moderate council meetings and appropriate reimbursement of travel costs. The costs associated with travel for council members and for the council facilitator would be expended on the Operating Expenses line in the budget.

The projected cost for the 2023-2025 biennium is \$77,640, of which, \$38,820 is General Fund and \$38,820 is Federal Funds.

For the 2023-2025 biennium the Department of Health and Human Services would need appropriation increase to the base level budget in SB 2012 to the line item Operating Expenses of \$77,640, of which, \$38,820 is General.

For the 2025-2027 biennium the Department of Human Services would need appropriation authority in the Operating Expenses line of \$80,746, of which, \$40,373 is General for the proposed changes in Engrossed SB2276.
