Engrossed SB2276 creates a new section to Chapter 50-06 related to the establishment of a cross-disability advisory council and a family caregiver service pilot project.

## 4 - Fiscal Impact Sections Detail

Section 1 of Engrossed SB2276 creates and enacts a new section to chapter 50-06 related to the appointment and duties of the cross-disability advisory council, the need for a facilitator, and allowance of members of the council to receive reimbursement for travel and lodging at the same rate as provided to state employees. Appropriation for the 2023-2025 biennium for the facilitator and reimbursement of the council members is included in Engrossed SB2012. No additional appropriation for Section 1 is needed.

Section 2 of Engrossed SB2276 creates and enacts a new section to chapter 50-24 related to a family caregiver service pilot project.

Section 3 of Engrossed SB2276 includes appropriation of \$2,500,000 in general fund to the Department for the purpose of establishing and issuing payments as part of a family caregiver service pilot project. Of this \$2,500,000, \$300,000 can be used by the Department to hire one full-time equivalent position to serve as the family caregiver service pilot project coordinator.

Section 1 of Engrossed SB2276 requires the Department of Health and Human Services to contract with a third-party vendor to act as a facilitator to moderate council meetings and appropriate reimbursement of travel costs. The costs associated with travel for council members and for the council facilitator would be expended on the Operating Expenses line in the budget. Appropriation for the projected cost for the 2023-2025 biennium is included in Engrossed SB2012 as Community Health Trust Fund.

Section 2 of Engrossed SB2276 requires the Department of Health and Human Services to establish a caregiver service pilot project. Appropriation for this, as well as for a full-time equivalent of \$2,500,000 in general funds is included in Section 3 of the bill.

For the 2023-2025 biennium, SB2276 includes appropriation of \$2,500,000 in general fund, \$300,000 of which can be utilized in the salary and fringe benefit line. The remaining \$2,200,000 would be in the medical grants line.
