SB 2201 reduces the maximum fee amounts for a registration certificate of dispensaries and manufacturing facilities and the maximum fee amount for additional plants (fees paid every two years). The bill would require the Department to pay the costs of criminal history record checks.

Section 2 and Section 7 require the Department of Health and Human Services (Department) to pay the costs of criminal history record checks. Section 1, Sections 3 through 5, and Section 8 reduce maximum fee amounts the Department may collect.

The Department projects the impact of reducing fees will reduce revenue by \$280,000 in the 23-25 biennium and the 25-27 biennium.
