Individuals 65 and older would be allowed to self-certify their qualifying debilitating medical condition to register as a qualifying patient in the Medical Marijuana Program. The application is online only. Programming costs would be incurred to implement changes.

The Department of Health and Human Services (Department) is required to develop a form to use in place of a written certification. As legislative intent appears to be a self-certification program for those 65 and older, the Department will not be using resources to verify information upon receipt of the electronic application.

While the Department anticipates an increase in the qualifying patient population, it is unknown what the impact may be. Thus, an impact on revenues is undetermined.

Since the Department will not be verifying self-certifications when those 65 and older use this method to apply, the Department is not identifying an expenditure amount. However, if the Department were to receive information on a number of potential false self-certifications, additional expenditures may be incurred as additional personnel would be needed for this additional workload. Also, if there were to be a significant increase to the qualifying patient population due to the self-certification, the Department may require additional personnel. The expenditure amount for the 21-23 Biennium of \$12,000 is for programming changes.
