If enacted, engrossed HB 1455 may reduce state general fund and state aid distribution fund revenues in the 2023-2025 biennium. The amount of the reduction in revenue is based on the quantity and amount of purchases for raw materials, single-use product contact systems, and reagents used for biologic manufacturing. Since the quantity and amounts for these qualifying purchases are unknown, the Office of State Tax Commissioner is unable to provide a reliable estimate for the revenue reduction amount.
