Increasing the Special Education weighting factor in the Foundation Aid Formula will increase the state aid distributed to school districts by \$103.7 million.

Increasing the Special Education weighting factor in the School Foundation Aid Funding Formula from .082 to .125 increases the Foundation Aid Formula by \$103.7 million. The projected cost for the special education weighting factor for the 2023-25 biennium is \$198 million at .082. Increasing the factor by over 50% would increase the total cost of the special education line to \$301 million.
