The cost for salaries and benefits of a judge is approximately \$132,600 more per biennium than a referee. The fiscal impact will depend on when the referee positions become vacant. The total cost to convert all five positions would be \$663,000 per biennium. For this fiscal note it is estimated that one referee position would be vacated in the 2023-25 biennium and two would be vacated in 2025-27.
