SB 2233 increases the number of participants at any one time in the attorney recruitment program from 4 to 8 attorneys.

**4 - Fiscal Impact Sections Detail**

The program provides a \$45,000 incentive to an attorney who agrees to practice in a qualifying rural county or municipality. The incentive is to be paid in equal annual installments over a 5 year period. The incentive is to be paid by the county or municipality (35%), the State Bar Association or other legal association (15%) and the Supreme Court (50%). The Supreme Court share of the incentive payments is \$4,500 per year per participant.
