Engrossed SB 2329 modifies the allocations to non-oil-producing townships from the township highway aid fund and modifies the allocations of motor vehicle excise tax collections to include the township highway aid fund and a new county aid highway fund.

Section 3 of engrossed SB 2329 will modify the transfer of revenue for moneys collected and received from the motor vehicle excise tax. The state treasurer shall allocate 25% of all moneys from motor vehicle excise tax to the township highway aid fund, 25% to the county highway aid fund, and the remaining 50% will go to the general fund.

If enacted, section 3 of engrossed SB 2329 will modify the transfer of moneys collected as part of the motor vehicle excise tax from 100% general fund to 25% township highway aid fund, 25% county highway aid fund, and 50% general fund. This will create a decrease of \$169,250,000 in the general fund, an increase of \$84,625,000 in the township highway aid fund, and an increase of \$84,625,000 in the county highway aid fund. These amounts are based on the January 2023 legislative forecast.
