HB 1430 creates a sales tax exemption for materials used in construction, expansion, or environmental upgrade of a renewable feedstock refinery.

4 - Fiscal Impact Sections Detail

Section 1 of HB 1430 will create a sales and use tax exemption for materials used in construction, expansion, or environmental upgrade of a renewable feedstock refinery. The exemption may be received only at the time of purchase. To receive the exemption, the owner of the renewable feedstock refinery must receive a certificate from the tax commissioner indicating the tangible personal property used to construct, expand, or make environmental upgrades to a renewable feedstock refinery that the owner intends to purchase qualifies for the exemption.

Section 3 of HB 1430 makes this exemption effective for taxable events occurring after 06/30/2023.

Section 1 of HB 1430 will create a reduction in revenue to both the general fund and the state aid fund on any eligible exemption claims. This reduction is based on the number of owners certified for the exemption, as well as the cost of the materials used in the construction, expansion, or environmental upgrade of a renewable feedstock refinery. Because these are unknown factors, the Office of State Tax Commissioner is unable to provide a reliable estimate for the revenue reduction amount.
