Senate Bill 2367 adjusts the amounts allocated for the state share of oil and gas tax collections.

Section 1 of SB 2367 modifies the allocation of the state's share of oil and gas tax collections by increasing the allocations to the State General Fund by \$60 M in total (increasing \$30 M to both General Fund buckets), Tax Relief Fund by \$30 M, & the first Strategic Investment and Improvement Fund bucket by \$60 M. By adjusting the allocations to these funds, it does prolong the possibility of some of the remaining buckets being filled. However, based on the current estimates, all buckets would fill within the biennium.

Section 1 of SB 2367 modifies the allocation of the state's share of oil and gas tax collections by increasing the allocations to the State General Fund by \$60 M which decreases the special funds \$60 M.
