SB 2372 relates to the creation and operation of watershed districts. It would add a filing entity type to FirstStop, the Secretary of State's business and licensing automated system.

On page 1, lines 10 - 17, a certified copy of the order creating a watershed district must be filed with the Secretary of State. The Secretary of State is to then issue to the department of water resources a certificate of the organization of the district and file a copy of the certificate and the commission's order creating the district.

On page 4, lines 8 – 11, provisions relating to a water resource district would apply to the watershed district.

The amount in Section 1 reflects the cost to program FirstStop to support this additional filing type in the same manner as the system supports water resource districts including initial filings, amendments, public search, copy requests, and certificates of fact.
