SB 2117 repeals NDCC 37-17.3-11 which exempts the statewide seamless base map record from section 44-04-18, authorizing the NDDDES State Radio Division director to charge a fee for the record. The base map is no longer maintained by NDDDES and the fee was not charged in previous biennium.

The repeal of NDCC 37-17.3-11 will have no fiscal impact.
