For 2023-25 we are estimating 3,000 of revenue: 23 plants (official establishments) x 50 = 1,15074 plants (custom exempt and any other establishment) x 25 = 1,850

For 2025-27 we are estimating \$400 of revenue: 6 plants (official establishments) x \$50 = \$3004 plants (custom exempt and any other establishment) x \$25 = \$100
