**3 - Bill and Fiscal Impact Summary**

SB2063, as amended, authorizes NDDOT to accept and expend National Electric Vehicle Infrastructure funds provided under the federal Bipartisan Infrastructure Law and related payments from non-federal entities to pay the non-federal matching share.

**4 - Fiscal Impact Sections Detail**

Federal National Electric Vehicle Infrastructure (NEVI) funds will be used to contract with private entities to acquire and install publicly accessible electric vehicle charging infrastructure; private entities will provide the non-federal share (20%). North Dakota's share of federal NEVI funding is \$25.95 million dollars over the next two biennia. The required 20% non-federal share is \$6.49 million.

The state revenue figure shown in part 1A for each biennium consists of \$3,245,000 from private entities. This does not include the \$12.975 million federal NEVI funds for each biennium.

The proceeds generated under this bill would be used to fund necessary electric vehicle charging infrastructure. The related expenditures will be incurred in two phases:

Phase 1: Alternate Fuel Corridors (I-94/I-29) - 23-25 biennium - Total: \$16.22 million

Phase 2: Other Highways/Locations – 25-27 biennium - Total: \$16.22 million

NDDOT estimates that \$16,220,000 will be expended in the 23-25 biennium and again in the 25-27 biennium. An increase to the NDDOT appropriation would be necessary to enable those expenditures.
