**REMARKS OF REPRESENTATIVE DAKANE**

John Tyler, another black cowboy, who was friends with one of North Dakota's favorite Presidents, Teddy Roosevelt.

William Montgomery, the owner of a 1,000-acre bonanza farm south of Fargo.

Frank Taylor, a highly respected horse dealer.

We honor these Americans, these North Dakotans during this Black History Month.

I would also ask us to reflect on the underlying reason to specifically have a month for Black History.

This country has been through quite a lot in its relatively short history. The battle for acceptance for everyone in our diverse country is prevalent. We have even seen civil wars as a result.

As we think about our country's past, of course we must note that we are not alone. Many bad things have happened to many people all across the world and all throughout history, but we can take that history to learn from it.

We are taking on a great historical task. To create a society that respects and treats fairly people from many very different backgrounds. We may not all have a long history of making Uffda.. . all good foods, but while I am up here, can I suggest you try (pick three foods you like Malawah with stew, jabati, or Sambus).

Differences aside, we share a common humanity. We love those who care for us, and those

we care for. We all want to contribute to a community, to be part of something bigger than ourselves.

Let's celebrate this month together as a step towards becoming an even stronger country, a country that recognizes the potential of everyone, even the ones who are a little different from us.

#### **STATEMENT OF PURPOSE OF AMENDMENT:**

This amendment:

- Removes a newly created agriculture infrastructure fund and a related contingent appropriation.
- Changes a legacy earnings fund allocation from a newly created agriculture infrastructure fund to the agriculture diversification and development fund.
- Adds tourism projects as eligible projects from the legacy projects fund.
- Allocates a portion of the funding exceeding the percent of market value to the legacy fund to become part of the principal.
