REMARKS OF REPRESENTATIVE MURPHY

MR. SPEAKER: Mr. Speaker and members of the Assembly, four young women from Grand Forks had an opportunity to compete in the 2023 USA Wrestling Girls Folkstyle Nationals held in Omaha, NE on March 3rd through the 5th. This is the premier national tournament for girls folkstyle wrestling.

For those of you unfamiliar with the different wrestling styles, folkstyle is a unique American style that is commonly found in high school or collegiate wrestling in the United States. For the Olympic styles, there is a separate USA Wrestling girls' tournaments in freestyle, but girls do not compete in the Greco-Roman style of wrestling.

Allyssa Johnson pinned her way to the championship with three pins after a first round bye. She had two pins under one minute, one of 58 seconds and one of 55 seconds. In the championship match at 144 pounds in the Junior Girls division, she won in a 12-7 decision over Presley Givens of Team Arkansas to be crowned national champion.

She represented Team North Dakota in this tournament and her accomplishment reflects her hard work in the room and the hard work of her partners as well. Her accomplishment recognizes all of the hardworking girls from across our great State of North Dakota who work in the wrestling room throughout the year to perfect their athletic prowess in the great sport of wrestling.

We wish the best for Allyssa in her wrestling career and look forward to seeing her accomplishments in the future.
