### **MEMORIAL ADDRESS BY HOWARD ANDERSON, FORMER SENATOR, DISTRICT 8**

Secretary of State Michael Howe, President of the Senate Tammy Miller, Leaders Hogue and Hogan, members of the families of the departed Senators, sitting Senators and friends.

Greetings from the Poet Laureate of the Senate (I just made that up from the Senate Bill you passed this session). I must have forgotten to ask the bill sponsors to include that provision in their bill.

To paraphrase Shakespeare from "As you like it"

"All the world is a stage wherein we each sit as spectators awhile and then act our own part in it"

All the world's a stage,  
And all the men and women merely players;  
They have their exits and their entrances;  
And one man in his time plays many parts,  
His acts being seven ages. At first the infant,  
Mewling and puking in the nurse's arms;  
And then the whining school-boy, with his satchel  
And shining morning face, creeping like snail  
Unwillingly to school. And then the lover,  
Sighing like furnace, with a woeful ballad  
Made to his mistress' eyebrow. Then a soldier,

Full of strange oaths, and bearded like the pard,  
 Jealous in honour, sudden and quick in quarrel,  
 Seeking the bubble reputation  
 Even in the cannon's mouth. And then the justice,  
 In fair round belly with good capon lin'd,  
 With eyes severe and beard of formal cut,  
 Full of wise saws and modern instances;  
 And so he plays his part. The sixth age shifts  
 Into the lean and slipper'd pantaloon,  
 With spectacles on nose and pouch on side;  
 His youthful hose, well sav'd, a world too wide  
 For his shrunk shank; and his big manly voice,  
 Turning again toward childish treble, pipes  
 And whistles in his sound. Last scene of all,  
 That ends this strange eventful history,  
 Is second childishness and mere oblivion;  
 Sans teeth, sans eyes, sans taste, sans everything.

These Senators we will honor today played their part in the stream of life and added to the lore and history of North Dakota with their service.

These distinguished men and women who have served as our Senators began serving North Dakota, first in the house of representatives in 1962, while I was still in high school. And some serving until 2007. These Senators covered a span of 45 years. They served a total of 128 years in the Senate and 54 in the House, an average of 15 years each.

Their average age was 87 years old. Which bodes well for all these sitting Senators for it means serving here is good for your health, or perhaps it means you need to be really tough to serve in the legislature.

I do wish to say a bit about each of our Senators. Most of the family may know these things, but may like to be reminded of them, however their service to the state was long ago, so some of us did not know them.

Jason Leroy Graba served his apprenticeship of three terms in the House and then moved to the Senate for the 52nd and 53rd legislative sessions. From a farm originally, he went to college in Bottineau where he played on the football team and met his wife, Helen. They moved to Riverdale where he worked in my back yard building the Garrison dam, which was at the time the largest earth filled dam in the world. He later moved to Minot and then Grand Forks where he served the local labor unions, then became the business agent for the city of Grand Forks until his retirement. Helen passed away in 1987 and he married Marilyn and they spent 32 years together. His proudest achievement after his family, was his service in the ND House and Senate.

James O. Kusler served the State of North Dakota in the Senate in the 48th and 49th sessions. He also was from a farm family near Beulah ND. He was a UND graduate with a master's degree in business administration from the American Graduate School of International Management. He worked closely with Governor Art Link. They developed strategies over pie and coffee at a local truck stop. He worked at Meyer Broadcasting and left to become a special assistant to ND Tax commissioner Kent Conrad then on to politics, winning a Senate seat and serving from 1983 to 1987. His last office in politics was as ND Secretary of State. From 1989 to 1993. He moved to the family farm and. Listen to this, he founded Brush Creek Certified Organic Beef long before most of us even thought about "organic". He co-hosted a radio talk show and wrote monthly for the Beulah Beacon. In his sixties he worked with CHS as a certified energy specialist in the Killdeer Oil Patch. He learned that if you listen more, you sell more, a good lesson for all of us.

Richard F Larsen was born in North Dakota and grew up in Grand Forks where he played hockey, baseball and spent summers on his grandparent's farm. Dick attended Harvard and between his sophomore and junior years he had the honor of serving in the United States Army. Returning to Harvard he graduated cum laude in 1960 with a bachelor of arts degree in economics. He went on to the London School of Economics where in 1963 he earned his PhD in agricultural economics.

He taught at UND and Moorhead State University. He served one term in the House and one in the Senate then on to serve as the state's Lieutenant Governor in 1969. In 1973 Dick was appointed by United States Secretary of the Treasury, George Schultz, to serve as deputy Assistant Secretary for Developing Nations Finance. His duties included oversight of the World Bank, Inter-American Development Bank and Asian Development Bank and handling debt negotiations with international banks and the U.S. Congress.

He later joined Bank of America and then Russell Reynolds & Associates both times as a Vice President, quite a career for this UND graduate. Then on to his own consulting firm and later traded his business suit for a fedora, which prompted me to remember the Irish poem by Edgar Allan Poe

Eldorado

BY EDGAR ALLAN POE

Gaily bedight,  
 A gallant knight,  
 In sunshine and in shadow,  
 Had journeyed long,  
 Singing a song,  
 In search of Eldorado.

But he grew old—

Marvin Mutzenberger was from Stanton ND. He was ordained in 1960. He spent 17 years in pastoral ministry serving 20 congregations throughout western ND. Marv's life at Bismarck Junior College began in 1979. During his 41 years there he taught psychology, sociology, and religious studies to an estimated 7000 students, coached baseball and cross country,

emceed numerous athletic events and gave hundreds of benedictions and invocations. He became active in the ND democratic-NPL party in 1972 serving as executive director of the state party and then 10 years as a ND representative and Senator from District 32. He was a great athlete at Stanton winning many long-distance races. Which, of course reminded me of Second Timothy 4:7-8; I have fought the good fight, I have finished the race, I have kept the faith. Now there is in store for me the crown of righteousness, which the Lord, the righteous Judge, will award to me on that day—and not only to me, but also to all who have longed for his appearing.

Donna Lou Nalewaja served North Dakota for 4 years in the House and then 12 years in the Senate. She graduated from the University of MN. She was active on many state and national committees and received many awards for her service. She was a licensed substitute teacher and a Antique dealer in her shop for 25 years.

James George Smykowski served four terms in the ND Senate. He was from Lidgerwood and he and his wife Annette raised seven children on their farm near Geneseo, ND. He was a real estate broker and for 55 years owned and operated Smykowski Auction service donating his services to Pheasants Forever, Bison Bidders Bowl and many others.

Big Jim, as he was called, was very active in local activities, serving on the Lidgerwood School Board, the Lidgerwood Community Development Corporation, the Board of Dakota Estates, the Geneseo Grain & Seed Company, first Bank of Lidgerwood, the local swimming pool Association and the 4-H foundation. He was involved in his church, the Elks, the Eagles, the Knights of Columbus, the Masonic Lodge and the El Zagal Shrine.  
In the State Pharmacist's Association, we have two awards for pharmacists based on the individual's involvement in their community. Big Jim would have won those awards.

Wayne K. Stenejhem is unique among those we remember today. He graduated from UND with a law degree. After a short two term apprenticeship in the House, he served 20 years in the Senate, then went on to be elected Attorney General where he served the State of North Dakota for another 21 years, becoming the longest serving Attorney General in ND History. I remember going to his office and learning that the proper way to address an Attorney General was General Stenejhem although he never expected it as just Wayne was good with him. Wayne led many tours of the capitol for visiting young people, As an Eagle Scout myself, I was very impressed with Wayne when in 2013 he was named a Distinguished Eagle Scout. Wayne was the youngest of those we remember today, at just 65 years old and he died while still in office, leaving his wife Beth and son Andrew.

To paraphrase Shakespeare a little:

The hourglass is a symbol of human life, see how quickly the sand runs. This is the state of man: to-day he puts forth The tender leaves of hope, tomorrow blossoms, And bears his blushing honours thick upon him: The next day comes a frost, which nips the shoot, And,—when he thinks, his greatness is still aspiring, nips his shoot and he falls like autumn leaves to enrich our mother earth.

There is a saying we use in Wood badge, where we train scout leaders, to honor those who have done a lot in scouting, "Who has smelled wood smoke at twilight, who has heard the birch log burning, who is quick to read the noises of the night? Then let him follow with the others for the young men's feet are turning, to the paths of known desire and proved delight."

Harvey Dean Tallackson served 32 years in the Senate. He was from a farm near Park River, ND. He was another Senator very active in his community. Zion Lutheran church, Walsh County alumni, Walsh Curling Club, State Curling Assn., the Masonic Lodge, Kem Temple Shriners, the County fair, the baseball League, Mandt Baseball team, the Farmers Union, Walsh County and ND milk producers, National Potato Advisory Committee, (I am not sure what they advised the potatoes to do), He was president of the National Conference of Insurance Legislators, and served as chair of the Senate Appropriations Committee. He served as Minkota Rural Electric Chairman from 1990 to 2005. He was a director of Nash

Grain and Trading and was president for their 75th anniversary. He was married to his Glenna for 73 ½ years.

Benjamin 'Ben' Tollefson spent 16 years serving ND in the House and then 8 years as a Senator. He was from Minot, joined the navy before WW II serving in the South Pacific sweeping mines from the pacific ports. He was honorably discharged in June of 1946. He worked at Nash finch and the Minot Daily News. in 1949 he married Lila and they had four children. He then joined Northern States Power and worked there for 32 years. He was a Jaycee and was Lieutenant Governor of Toastmasters International. He received the "Citizen of the year award from NSP and was disaster chairman in Minot during the 1969 flood. He received the Clara Barton Honor from the Red Cross. He was president of the Lutheran Church Council in Minot and served as President and Lieutenant governor of Kiwanis International. As a legislator he received the North Dakota Lignite Council Award.

John Thomas "Jack" Traynor from Devils Lake. He attended the US Naval Academy in Annapolis and was honorably discharged in 1946. He and Senator Tollefson had the Navy in common. He earned his Juris doctorate from UND in 1951. He married Jane in 1954 and they raised five children. They lived a life filled with faith, family, civic volunteerism, and leadership activities. He was a hunter and a fisherman and could remember hunting ducks on the east bay of Devils Lake when it was just a slough.

He joined his father in the Traynor Law Firm and later added his two sons, J. Thomas Jr. and Dan Traynor.

He served on the Board for the UND Alumni Association and foundation and earned the Sioux Award in 1969. He served on the Lake Region College Foundation and was inducted into their Hall of Fame.

He was elected Grand Exalted Ruler (National President) of the Elks when they had 1.6 million members. He and Jane traveled to 48 states and two territories.

He worked in the legislature to provide for an outlet to Devils Lake. His attempts in 1997 and 1999, depended on Federal funds and in 2001 ND legislation provided for an outlet with or without Federal funds and in 2003 it was finally built. Jack, as a member of the bar association, helped create the lawyer disciplinary system used in North Dakota.

I remember John Wayne in one of his movies. They were chasing some bad men and approached the Rio Grand in west Texas. The foreman said he had heard there was no law west of the Rio Grand and no God west of the Pecos.

John Wayne replied, "Wherever men go the law will always follow and sooner or later they will discover that God has already been there".

Frances E. "Hank" Weber spent 16 years in the House. He started out there in the 38th session, then served the 39th in the Senate. He must not have liked the Senate much because he went back to the house for another 14 years. Maybe redistricting had something to do with it? He was a farmer and received a teaching degree from Valley City State. He taught both in ND and MN. He player on the College Basketball team and played for many years in the amateur basketball league and baseball teams.

He married Dona in 1955 and they raised two sons, Todd and Mark. Mark is with us today and true to his father's legacy you can hear him ask, "How will that bill affect the townships".

I remembered the poet saying when he retired. "No I am through, the trumpet call of youth must sound in vain, for I have need of rest. Leave me to books and wine and memories, nothing you have can equal these."

Stanley "Stan" Wright was another farmer from Stanley, ND. Quite a musician and member of the family 'Melody Kings' with his mother on the piano, his dad on the fiddle, and the boys on the trombone, saxophone, and clarinet. They played many dances in the Stanley area. He was a Senator serving 16 years for ND. He served in the army at the end of WW II and then in Korea. He played his trombone for the army band. He married Mavis and they raised three daughters.

Stan first worked for John Deere, then owned the International Harvester (Stanley Equipment) dealership for many years. He spent 50 years as a public servant, City Council, Mayor, State Senator, County Commissioner. He was proud of getting Highway 2, four laned while serving in the Senate.

Stan, like those we have already discussed, was very active in his community America Legion, VFW, Lions Club, volunteer fireman, Stanley Veterans Park, Scandia American Bank, Community Hospital Board, the fair association and the Lutheran church.

 Make thee to shudder, and grow sick at heart;—

 Comes a still voice—

Yet a few days, and thee  
 The all-beholding sun shall see no more  
 In all his course; nor yet in the cold ground,

So live, that when thy summons comes to join
