

PROPOSED AMENDMENTS TO SENATE AND HOUSE RULES 204

1 **SECTION 1. AMENDMENT.** Senate Rule 204 is amended as follows:

2 **204. Preparation and distribution of the journal.**

- 3 1. Upon completion of the Senate journal for a legislative day, the Secretary shall deliver  
 4 to the printer having the contract for printing the legislative journals a complete copy of  
 5 the Senate journal.
- 6 2. Before the Senate goes into session again, the Committee on Correction and Revision  
 7 of the Journal shall carefully examine and review the journal of the previous legislative  
 8 day. The committee shall note any errors or omissions and report the errors or  
 9 omissions to the Senate for action.
- 10 3. The printer shall set aside ~~twenty-four~~ the number of copies of the daily journal  
 11 required under subsection 4. Upon termination of the legislative session, the printer  
 12 shall deliver these copies to the contract binder, who shall assemble the copies into  
 13 ~~twenty-four~~ the required sets of permanent journals.
- 14 4. The permanent journals must be bound in hard covers and deposited with the  
 15 ~~Secretary of State~~ Legislative Council. The ~~Secretary of State~~ Legislative Council shall  
 16 ~~preserve two~~ retain one set for the Legislative Council office and deliver:
- 17 a. ~~Two sets and~~ to the Secretary of State, who shall attach the Secretary of State's  
 18 certificate to those sets showing the date of delivery and attesting that the copies  
 19 are identical and official journals as delivered to the Secretary of State. ~~From the~~  
 20 ~~remaining sets, the Secretary of State shall forward one;~~
- 21 b. One set to the Senate;
- 22 c. One set to the House;
- 23 d. One set to the Supreme Court Library, ~~one;~~
- 24 e. One set to the Law School Library at the University of North Dakota, ~~eight sets to~~  
 25 ~~the State Library, three sets to the Legislative Council, one set to the Secretary of~~  
 26 ~~the Senate, and one set to each judicial district as determined by the presiding~~  
 27 ~~judge of the district. The; and~~
- 28 f. The number of sets set aside in subsection 3 and delivered to the State Library  
 29 may be reduced by five if required under North Dakota Century Code Section

3       **SECTION 2. AMENDMENT.** House Rule 204 is amended as follows:

4       **204. Preparation and distribution of the journal.**

- 5       1. Upon completion of the House journal for a legislative day, the Chief Clerk shall deliver  
6           to the printer having the contract for printing the legislative journals a complete copy of  
7           the House journal.
- 8       2. Before the House goes into session again, the Committee on Correction and Revision  
9           of the Journal shall carefully examine and review the journal of the previous legislative  
10          day. The committee shall note any errors or omissions and report the errors or  
11          omissions to the House for action.
- 12      3. The printer shall set aside ~~twenty-four~~ the number of copies of the daily journal  
13          required under subsection 4. Upon termination of the legislative session, the printer  
14          shall deliver these copies to the contract binder, who shall assemble the copies into  
15          ~~twenty-four~~ the required sets of permanent journals.
- 16      4. The permanent journals must be bound in hard covers and be deposited with the  
17          ~~Secretary of State~~ Legislative Council. The ~~Secretary of State~~ Legislative Council shall
