1 A BILL for an Act to provide an appropriation for defraying the expenses of the parks and
2 recreation department; and to provide for a transfer.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from other funds derived from special funds and
7 federal funds, to the parks and recreation department for the purpose of defraying the expenses
8 of the parks and recreation department and for providing a grant to the International Peace
9 Garden, for the biennium beginning July 1, 2025, and ending June 30, 2027, as follows:

10 **SECTION 2. TRANSFER - GAME AND FISH DEPARTMENT TO PARKS AND**

11 **RECREATION DEPARTMENT - GAME AND FISH OPERATING FUND - BOAT RAMP**

12 **OPERATION AND MAINTENANCE.** The sum of \$122,000, or so much of the sum as may be
 13 necessary, included in the park operations and maintenance line item in subdivision 1 of
 14 section 1 of this Act, is from the game and fish operating fund, or federal or other funds
 15 available to the game and fish department, which must be transferred to the parks and
 16 recreation department for maintenance, operating, and extraordinary repairs expenses relating
 17 to boat ramps at state parks for the biennium beginning July 1, 2025, and ending June 30,
 18 2027.
