7	treasury, not otherwise appropriated, and from special funds derived from the insurance					
8	regulatory trust fund, not otherwise appropriated, to the legislative branch of state government					
9	for the purpose of defraying the expenses of the legislative branch of state government, for the					
10	fiscal period beginning with the effective date of this Act, and ending June 30, 2027, as follows:

14	SECTION 2. EXEMPTION - TRANSFERS. Notwithstanding section 54-16-04, the director					
15	of the office of management and budget shall transfer appropriation authority between line items					
16	of the legislative management and legislative council as may be requested by the chairman of					
17	the legislative management or the director of the legislative council upon the finding by the					
18	chairman or the director that the nature of studies and duties assigned to the legislative					
19	management or legislative council requires the transfers in properly carrying on the legislative					
20	management's and legislative council's functions and duties. The director of the office of					
21	management and budget shall similarly make transfers of appropriation authority between the					
22	line items for the sixty-ninth and seventieth legislative assemblies, upon request by the					

SECTION 3. APPLICATION, TRANSFER AUTHORITY, AND CANCELLATION OF UNEXPENDED APPROPRIATIONS. Sections 54-16-04 and 54-44.1-11 do not apply to chapter 1 of the 2023 Session Laws. The director of the office of management and budget shall make transfers of appropriation authority between the line items and the agencies of the legislative branch within section 1 of that chapter as requested by the chairman of the legislative management or the director of the legislative council. The office of management and budget

- 1 shall cancel unexpended appropriations for the legislative assembly and legislative council

- 4 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
