**PROPOSED AMENDMENTS TO
FIRST ENGROSSMENT**

ENGROSSED SENATE BILL NO. 2010

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the council on the
2 arts; to provide for a transfer; to provide for a report; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from other funds derived from special funds and
7 federal funds, to the council on the arts for the purpose of defraying the expenses of the council
8 on the arts, for the biennium beginning July 1, 2025, and ending June 30, 2027, as follows:

7 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**

8 **SEVENTIETH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding
 9 items included in the appropriation in section 1 of this Act which are not included in the entity's
 10 base budget for the 2027-29 biennium and which the entity shall report to the appropriations
 11 committees of the seventieth legislative assembly regarding the use of this funding:

15 **SECTION 3. APPROPRIATION - CULTURAL ENDOWMENT FUND.** All income from the
 16 cultural endowment fund is appropriated to the council on the arts for the furthering of the
 17 cultural arts in the state for the biennium beginning July 1, 2025, and ending June 30, 2027.

18 The council on the arts may use up to ~~\$190,000~~ \$380,000 of moneys in the cultural endowment
 19 fund for maintenance or for construction of arts across the prairie projects, for the biennium
 20 beginning July 1, 2025, and ending June 30, 2027. The council on the arts may use up to
 21 \$454,142 of moneys designated for maintenance in the cultural endowment fund for arts across
 22 the prairie site preparation and installation costs.

23 **SECTION 4. APPROPRIATION - GIFTS, GRANTS, AND BEQUESTS.** All gifts, grants,
 24 devises, bequests, donations, and assignments received by the council on the arts are
 25 appropriated to the council on the arts for the purposes provided in section 54-54-06, for the
 26 biennium beginning July 1, 2025, and ending June 30, 2027.

27 **SECTION 5. NEW AND VACANT FTE POOL - LIMITATION - TRANSFER REQUEST.** The
 28 council on the arts may not spend funds appropriated in the new and vacant FTE pool line item
 29 in section 1 of this Act, but may request the office of management and budget to transfer funds
 30 from the new and vacant FTE pool line item to the salaries and wages line item in accordance

1 with the guidelines and reporting provisions included in House Bill No. 1015, as approved by the
2 sixty-ninth legislative assembly.

3 **SECTION 6. STATE TROUBADOUR - POET LAUREATE.** The grants line item in section 1
4 of this Act includes \$15,000 for the state troubadour and \$15,000 for the poet laureate.

5 **SECTION 7. EXEMPTION - LINE ITEM TRANSFERS - REPORT.** Notwithstanding section
6 54-16-04, the director of the office of management and budget shall transfer funds between line
7 items, excluding the new and vacant FTE pool line item, in section 1 of this Act as requested by
8 the council on the arts. The council on the arts shall notify the legislative council of any transfer
9 made pursuant to this section. The council on the arts shall report to the budget section after
10 June 30, 2026, any transfer made in excess of \$50,000 and to the appropriations committees of
11 the seventieth legislative assembly regarding any transfers made pursuant to this section.

12 **SECTION 8. EXEMPTION - UNEXPENDED APPROPRIATION.** The amount of \$25,000
13 appropriated from the general fund for the purpose of accrued leave payouts in section 1 of
14 chapter 10 of the 2023 Session Laws is not subject to section 54-44.1-11 and any unexpended
15 funds may be continued and are available to the council on the arts for costs relating to accrued
16 leave payouts during the biennium beginning July 1, 2025, and ending June 30, 2027.
