- 1 A BILL for an Act to create and enact chapter 43-17.5 of the North Dakota Century Code,
- 2 relating to the physician assistant licensure compact.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Chapter 43-17.5 of the North Dakota Century Code is created and enacted as
follows:

6 <u>43-17.5-01. Purpose.</u>

- In order to strengthen access to medical services, and in recognition of the advances
 in the delivery of medical services, the participating states of the physician assistant
 licensure compact have allied in common purpose to develop a comprehensive
- 10 process that complements the existing authority of state licensing boards to license
- 11 and discipline physician assistants and seeks to enhance the portability of a license to
- 12 practice as a physician assistant while safeguarding the safety of patients.
- 13 <u>2.</u> <u>This compact:</u>
- 14a.Allows medical services to be provided by physician assistants, via the mutual15recognition of the licensee's qualifying license by other compact participating16states.
- 17 <u>b.</u> <u>Adopts the prevailing standard for physician assistant licensure.</u>
- c. Affirms the practice and delivery of medical services by the physician assistant
 occurs where the patient is located at the time of the patient encounter, and
 therefore requires the physician assistant to be under the jurisdiction of the state
 licensing board where the patient is located.
- 3. State licensing boards that participate in this compact retain the jurisdiction to impose
 adverse action against a compact privilege in that state issued to a physician assistant
- 24 through the procedures of this compact. The physician assistant licensure compact will

1		alleviate burdens for military families by allowing active duty military personnel and					
2		their spouses to obtain a compact privilege based on having an unrestricted license in					
3		good standing from a participating state.

7		permitted by a state's laws which is imposed by a licensing board or other authority

10		licensee, or restriction on the licensee's practice.					
11	<u>2.</u>	"Compact privilege" means the authorization granted by a remote state to allow a					
12		licensee from another participating state to practice as a physician assistant to provide					
13		medical services and other licensed activity to a patient located in the remote state					
14		under the remote state's laws and regulations.					
15	<u>3.</u>	"Conviction" means a finding by a court that an individual is guilty of a felony or					
16		misdemeanor offense through adjudication or entry of a plea of guilt or no contest to					
17		the charge by the offender.					
18	<u>4.</u>	"Criminal background check" means the submission of fingerprints or other biometric-					
19		based information for a license applicant for the purpose of obtaining that applicant's					
20		criminal history record information, as defined in 28 C.F.R. § 20.3(d), from the state's					
21		criminal history record repository as defined in 28 C.F.R. § 20.3(f).					
22	<u>5.</u>	"Data system" means the repository of information about licensees, including license					
23		status and adverse actions, which is created and administered under the terms of this					
24		compact.					
25	<u>6.</u>	"Executive committee" means a group of directors and ex officio individuals elected or					
26		appointed under section 43-17.5-07.					
27	<u>7.</u>	"Impaired practitioner" means a physician assistant whose practice is adversely					
28		affected by health-related conditions that impact their ability to practice.					
29	<u>8.</u>	"Investigative information" means information, records, or documents received or					
30		generated by a licensing board pursuant to an investigation.					

1	<u>9.</u>	"Jurisprudence requirement" means the assessment of an individual's knowledge of
2		the laws and rules governing the practice of a physician assistant in a state.
3	<u>10.</u>	"License" means current authorization by a state, other than authorization pursuant to
4		a compact privilege, for a physician assistant to provide medical services, which would
5		be unlawful without current authorization.
6	<u>11.</u>	"Licensee" means an individual who holds a license from a state to provide medical
7		services as a physician assistant.
8	<u>12.</u>	"Licensing board" means any state entity authorized to license and otherwise regulate
9		physician assistants.
10	<u>13.</u>	"Medical services" means health care services provided for the diagnosis, prevention,
11		treatment, cure or relief of a health condition, injury, or disease, as defined by a state's
12		laws and regulations.
13	<u>14.</u>	"Model compact" means the model for the physician assistant licensure compact on
14		file with the council of state governments or other entity as designated by the
15		commission.
16	<u>15.</u>	"Participating state" means a state that has enacted this compact.
17	<u>16.</u>	"Physician assistant" means an individual who is licensed as a physician assistant in a
18		state. For purposes of this compact, any other title or status adopted by a state to
19		replace the term "physician assistant" is deemed synonymous with "physician
20		assistant" and confers the same rights and responsibilities to the licensee under the
21		provisions of this compact at the time of its enactment.
22	<u>17.</u>	"Physician assistant licensure compact commission", "compact commission", or
23		"commission" mean the national administrative body created pursuant to section
24		<u>43-17.5-07 of this compact.</u>
25	<u>18.</u>	"Qualifying license" means an unrestricted license issued by a participating state to
26		provide medical services as a physician assistant.
27	<u>19.</u>	"Remote state" means a participating state where a licensee who is not licensed as a
28		physician assistant is exercising or seeking to exercise the compact privilege.
29	<u>20.</u>	"Rule" means a regulation promulgated by an entity that has the force and effect of
30		law.

24			seeking to practice under the compact privilege and pay any fees applicable to
25			satisfying the jurisprudence requirement; and
26		<u>j.</u>	Report to the commission any adverse action taken by a nonparticipating state
27			within thirty days after the action is taken.
28	<u>2.</u>	<u>The</u>	compact privilege is valid until the expiration or revocation of the qualifying license
29		unle	ess terminated pursuant to an adverse action. The licensee shall comply with the
30		req	uirements of subsection 1 to maintain the compact privilege in a remote state. If the

1		a. <u>Take adverse action against a physician assistant's compact privilege within that</u>
2		state to remove a licensee's compact privilege or take other action necessary
3		under applicable law to protect the health and safety of its citizens.
4		b. Issue subpoenas for both hearings and investigations that require the attendance
5		and testimony of witnesses as well as the production of evidence. Subpoenas
6		issued by a licensing board in a participating state for the attendance and
7		testimony of witnesses or the production of evidence from another participating
8		state must be enforced in the latter state by any court of competent jurisdiction,
9		according to the practice and procedure of that court applicable to subpoenas
10		issued in proceedings pending before it. The issuing authority shall pay any
11		witness fees, travel expenses, mileage and other fees required by the service
12		statutes of the state in which the witnesses or evidence are located.
13	<u>3.</u>	Notwithstanding subsection 2, subpoenas may not be issued by a participating state to
14		gather evidence of conduct in another state that is lawful in that other state for the
15		purpose of taking adverse action against a licensee's compact privilege or application
16		for a compact privilege in that participating state.
17	<u>4.</u>	This compact does not authorize a participating state to impose discipline against a
18		physician assistant's compact privilege or to deny an application for a compact
19		privilege in that participating state for the individual's otherwise lawful practice in
20		another state.
21	<u>5.</u>	For purposes of taking adverse action, the participating state which issued the
22		qualifying license shall give the same priority and effect to reported conduct received
23		from any other participating state as it would if the conduct had occurred within the
24		participating state which issued the qualifying license. In so doing, that participating
25		state shall apply its own state laws to determine appropriate action.
26	<u>6.</u>	A participating state, if otherwise permitted by state law, may recover from the affected
27		physician assistant the costs of investigations and disposition of cases resulting from
28		any adverse action taken against that physician assistant.
29	<u>7.</u>	A participating state may take adverse action based on the factual findings of a remote
30		state, provided the participating state follows its own procedures for taking the adverse
31		action.

1 Joint investigations. 8. 2 In addition to the authority granted to a participating state by its respective state <u>a.</u> 3 physician assistant laws and regulations or other applicable state law, any 4 participating state may participate with other participating states in joint 5 investigations of licensees. 6 b. Participating states shall share any investigative, litigation, or compliance 7 materials in furtherance of any joint or individual investigation initiated under this 8 compact. 9 If an adverse action is taken against a physician assistant's qualifying license, the 9. 10 physician assistant's compact privilege in all remote states must be deactivated until 11 two years have elapsed after all restrictions have been removed from the state 12 license. All disciplinary orders by the participating state which issued the qualifying 13 license that impose adverse action against a physician assistant's license must 14 include a statement that the physician assistant's compact privilege is deactivated in 15 all participating states during the pendency of the order. 16 If any participating state takes adverse action, it promptly shall notify the administrator 10. 17 of the data system. 18 43-17.5-07. Establishment of the physician assistant licensure compact commission. 19 The participating states hereby create and establish a joint government agency and 1. 20 national administrative body known as the physician assistant licensure compact 21 commission. The commission is an instrumentality of the compact states acting jointly 22 and not an instrumentality of any one state. The commission comes into existence on 23 or after the effective date of the compact as set forth in section 43-17.5-11. 24 2. Membership, voting, and meetings. 25 Each participating state must have and be limited to one delegate selected by <u>a.</u> 26 that participating state's licensing board or, if the state has more than one 27 licensing board, selected collectively by the participating state's licensing boards. 28 The delegate must be either: b. 29 (1) A current physician assistant, physician, public member of a licensing board, 30 or physician assistant council or committee; or 31 (2) An administrator of a licensing board.

1		<u>c.</u>	Any delegate may be removed or suspended from office as provided by the laws
2			of the state from which the delegate is appointed.
3		<u>d.</u>	The participating state licensing board shall fill any vacancy occurring in the
4			commission within sixty days.
5		<u>e.</u>	Each delegate is entitled to one vote on all matters voted on by the commission
6			and shall otherwise have an opportunity to participate in the business and affairs
7			of the commission. A delegate may vote in person or by such other means as
8			provided in the bylaws. The bylaws may provide for delegates' participation in
9			meetings by telecommunications, video conference, or other means of
10			communication.
11		<u>f.</u>	The commission shall meet at least once during each calendar year. Additional
12			meetings must be held as set forth in this compact and the bylaws.
13		<u>g.</u>	The commission shall establish by rule a term of office for delegates.

8		all times the commission avoids any appearance of impropriety or conflict of

11		hold, improve or use, any property, real, personal or mixed; provided the

4		<u>d.</u>	The commission may not incur obligations of any kind prior to securing the funds
5			adequate to meet the same; nor may the commission pledge the credit of any of
6			the participating states, except by and with the authority of the participating state.
7		<u>e.</u>	The commission shall keep accurate accounts of all receipts and disbursements.
8			The receipts and disbursements of the commission are subject to the financial
9			review and accounting procedures established under its bylaws. All receipts and
10			disbursements of funds handled by the commission are subject to an annual
11			financial review by a certified or licensed public accountant, and the report of the
12			financial review must be included in and become part of the annual report of the
13			commission.
14	<u>6.</u>	The	executive committee.
15		<u>a.</u>	The executive committee may act on behalf of the commission according to the
16			terms of this compact and commission rules.
17		<u>b.</u>	The executive committee must be composed of nine members:
18			(1) Seven voting members who are elected by the commission from the current
19			membership of the commission;
20			(2) One ex officio, nonvoting member from a recognized national physician
21			assistant professional association; and
22			(3) One ex officio, nonvoting member from a recognized national physician
23			assistant certification organization.
24		<u>c.</u>	The ex officio members will be selected by their respective organizations.
25		<u>d.</u>	The commission may remove any member of the executive committee as
26			provided in its bylaws.
27		<u>e.</u>	The executive committee shall:
28			(1) Meet at least annually:
29			(2) Recommend to the commission changes to the commission's rules or
30			bylaws, changes to this compact legislation, fees to be paid by compact

1				participating states including annual dues and any commission compact fee
2				charged to licensees for the compact privilege;
