- **SECTION 1. AMENDMENT.** Section 39-09-01 of the North Dakota Century Code is amended and reenacted as follows:

- 9 An individual may not drive a vehicle at a speed greater than is reasonable and <u>1.</u> 10 prudent under the conditions and havingshall drive with regard to the existing actual 11 and potential hazards then existing. Consistent with the foregoing, every person. An 12 individual shall drive at a safe and appropriate speed when approaching and crossing 13 an intersection or railroad grade crossing, when approaching and going around a 14 curve, when approaching a hill crest, when traveling upon any narrow or winding 15 roadway, and when special hazards exist with respect to pedestrians or, other traffic or-16 by reason of, weather, or highway conditions. Any personAn individual who drives a 17 vehicle upon a highway or private or public property open to the public for the 18 operation of motor vehicles without heed to in violation of the requirements or 19 restrictions of this section has committed is quilty of careless driving and must be 20 assessed a fee of thirtyone hundred dollars.
