ENGROSSED HOUSE BILL NO. 1431

- 1 A BILL for an Act to amend and reenact sections 16.1-03-01, 16.1-03-07, 16.1-03-11,
- 2 16.1-03-14, and 16.1-03-22 of the North Dakota Century Code, relating to political

3 organizations; and to repeal sections 16.1-03-03, 16.1-03-05, 16.1-03-08, and 16.1-03-17 of the

4 North Dakota Century Code, relating to district parties and district committees.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 16.1-03-01 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 16.1-03-01. Party caucus - Time and manner of holding - Caucus call - Notice.

- 9 1. Each legislative district party shall organize in conformance with the state legislative
 10 district boundaries as established by the legislative assembly and as set forth under
 11 chapter 54-03.
- 12 2. On or before May fifteenth following the last preceding general election <u>and after</u>
- redistricting of the legislative assembly becomes effective, a party caucus must be
 held by every legislative district party. The legislative district party may organize the
 caucus by precinct or on an at-large basis for the entire district.
- The legislative district chairman of each party shall set the date and time for the party
 caucus. If there is not a duly elected district chairman in a legislative district, the state
 party executive committee may issue the call for the caucus. The call must contain the
 following:
- 20 a. Name of party.
- 21 b. Legislative district number.
- 22 c. Date of caucus.

2		e.	Hours of caucus.	
3		f.	A statement of the business to be conducted, including participation requirements	
4			established by state party and district bylaws or rules.	
5		g.	The name of the district chairman or, if there is not a duly elected district	
6			chairman, the membername and contact information of the state party executive-	
7			committee issuing the call.	
8	4.	The	district chairman or, if there is not a duly elected district chairman, the state party	
9		exe	cutive committee shall provide ten days' published notice in the official newspaper	
10		in c	irculation in the district. The notices must contain that the information set forth	
11		<u>inpr</u>	ovided under subsection 3.	
12	<u>5.</u>	Witl	Within thirty days of the effective date of a redistricting of the legislative assembly, the	
13		<u>stat</u>	e committee shall issue a call of a party caucus if:	
14		<u>a.</u>	A district does not share any geographical area with the same numbered district	
15			before the most recent redistricting; or	
16		<u>b.</u>	A district with new geographic area has a population within the new geographic	
17			area more than twenty-five percent of the district's total population as determined	
18			in the most recent federal decennial census.	
19	SECTION 2. AMENDMENT. Section 16.1-03-07 of the North Dakota Century Code is			
20	amended and reenacted as follows:			
21	16.1-03-07. Meeting of district committee - Organization.			
22	1.	lf a	legislative district chooses to organize by precinct in every odd-numbered year, the	
23		dist	rict committee of each party shall meet within fifteen days after the caucus	
24		prov	vided for in section 16.1-03-01. The day, hour, and site must be set by the existing	
25		dist	rict committee chairman. Any incumbent members of the legislative assembly from	
26		the	party and any other individual provided for by the district committee's bylaws	
27		con	stitute the district committee of the party. The<u>At</u> each party caucus, the district	
28		con	mittee of a party must be organized to coincide with the geographical boundary	
29		line	s of state legislative districts. Each member of any committee provided for in this	
30		cha	pter must be a qualified elector.	

1	2.	The district committee shall select the officers of the district committee and forward to		
2		the state committee the name and contact information of the district committee		
3		chairman. The district committee may appoint an executive committee consistent with		
4		the bylaws of the district committee. That party's nominees for and members of the		
5		legislative assembly shall serve as members of the executive committee.		
6	3.	If the office of chairman becomes vacant, the vacancy may be filled as provided by the		
7		district party bylaws.		
8	4.	The bylaws of the state committee or state party may not include any requirement		
9		providing directives or procedures for the method of the organization of district		
10		committees nor may the state committee or state party take any action or impose any		
11		requirement regarding district party organization unless a district lacks a district		
12		committee that is able to carry out the responsibilities under this chapter. A state party-		
13		may not take any action that is inconsistent with this chapter.		
14	5.	After redistricting of the legislative assembly becomes effective, the state party chair-		
15		may appoint a temporary district party organization chair in any newly established		
16		district or a district that lacks a district committee able to carry out the responsibilities		
17		of this chapter. The temporary district party organization chair shall organize the		
18		district political party as closely as possible in conformance with this chapter to assure		
19		compliance with primary election filing deadlines.		
20	SECTION 3. AMENDMENT. Section 16.1-03-11 of the North Dakota Century Code is			
21	amende	d and reenacted as follows:		
22	16.1	-03-11. State committee - Meetings - Organization.		
23	<u>On c</u>	or before July first of each odd-numbered year, a political party shall organize a state		
24	committee by electing officers as provided for by its bylaws or rules. The state committee shall-			
25	meet on or before July first of each odd-numbered year. The committee shall organize by			
26	selecting officers as provided for byparty consists of the chairman of district committees of the			
27	party and any individual provided for under the state committeeparty bylaws and by adopting-			
28	rules and modes of procedure, including rules and procedures regarding the selection of state			
29	convention delegatesor rules. Within thirty days following the state committee's organization,			
30	the newl	y elected chairman shall notify the secretary of state of the names of the party officers		

1 selected Within thirty days, the newly elected state chairman shall notify the secretary of state of 2 the names of the party officers elected. 3 SECTION 4. AMENDMENT. Section 16.1-03-14 of the North Dakota Century Code is amended and reenacted as follows: 4 5 16.1-03-14. State party convention. The state party state committeechairman shall set the place and time of the state party 6 1. 7 convention to be held in each general election year. Subject to party rules and bylaws, 8 the state party convention may: 9 Adopt rules to govern a convention held under this section. a. 10 b. Nominate the legal number of elector nominees and alternate elector nominees 11 for its party for the offices of presidential electors. The nominees must be 12 qualified electors of this state. 13 Elect the required number of delegates and alternates to the national party b.c. 14 convention. 15 c.<u>d.</u> Endorse candidates as provided under subsection 2. 16 2. The candidate or candidates for endorsement or election must be declared endorsed 17 or elected under the rules of the party, and the chairman and secretary of the 18 convention shall issue certificates of endorsement as provided in section 16.1-11-06 or 19 certificates of election. The names of the gualified electors nominated for presidential 20 electors the party wishes to place on the general election ballot must be certified by 21 the chairman and secretary of the convention to the secretary of state by four p.m. on 22 the sixty-fourth day before the general election to be placed upon the general election 23 ballot as provided in section 16.1-06-07.1. 24 SECTION 5. AMENDMENT. Section 16.1-03-22 of the North Dakota Century Code is 25 amended and reenacted as follows: 26 16.1-03-22. Liability of officers and members. 27 1. Officers and executive committee membersof a political party organization are immune 28 from civil liability for any act or omission relating to their service or function as an 29 officer or executive committee member, unless the act or omission constitutes gross or 30 willful negligence or gross or willful misconduct.

- 1 2. Members of a political organization are neither obligated to pay, nor liable upon, any
- 2 political organization obligation.
- **SECTION 6. REPEAL.** Sections 16.1-03-03, 16.1-03-05, 16.1-03-08, and 16.1-03-17 of the
