- 1 A BILL for an Act to create and enact a new subdivision to subsection 2 of section 39-06.1-06.
- 2 and a new section to chapter 39-21 of the North Dakota Century Code, relating to the use of an
- 3 engine compression brake device; to amend and reenact section 39-06.1-09 of the North
- 4 Dakota Century Code, relating to the definition of a moving violation; and to provide a penalty.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1.** A new subdivision to subsection 2 of section 39-06.1-06 of the North Dakota
- 7 Century Code is created and enacted as follows:
- 8 <u>A violation of section 3 of this Act, a fee of fifty dollars.</u>
- 9 **SECTION 2. AMENDMENT.** Section 39-06.1-09 of the North Dakota Century Code is
- 10 amended and reenacted as follows:
- 11 39-06.1-09. Moving violation defined.
- For the purposes of sections 39-06.1-06 and 39-06.1-13, a "moving violation" means a
- 13 violation of section 39-04-11, 39-04-22, subsection 1 of section 39-04-37, section 39-04-55,
- 14 39-06-01, 39-06-04, 39-06-14, 39-06-14.1, 39-06-16, 39-06.2-07, 39-08-20, 39-08-23, 39-08-24,
- 15 39-08-25, 39-09-01, 39-09-01.1, 39-09-04.1, or 39-09-09, subsection 1 of section 39-12-02,
- 16 section 39-12-04, 39-12-05, 39-12-06, 39-12-09, 39-19-03, 39-21-45.1, section 3 of this Act.
- section 39-24-02, or 39-24-09, except subdivisions b and c of subsection 5 of section 39-24-09,
- or equivalent ordinances; or a violation of the provisions of chapter 39-10, 39-10.2, 39-21, or
- 19 39-27, or equivalent ordinances, except subsection 5 of section 39-10-26, section 39-21-44,
- and subsections 2 and 3 of section 39-21-46, and those sections within those chapters which
- are specifically listed in subsection 1 of section 39-06.1-08.
- **SECTION 3.** A new section to chapter 39-21 of the North Dakota Century Code is created
- 23 and enacted as follows:

## 1 <u>Engine compression brake device - Prohibited.</u>

- An operator of a motor vehicle may not use an engine compression brake device in a
  zone posted as prohibiting the use of an engine compression brake device.
- 2. Subsection 1 does not apply to the use of an engine compression brake device during
  an emergency situation.
