- 1 A BILL for an Act to create and enact two new sections to chapter 26.1-30, two new sections to
- 2 chapter 26.1-39, a new section to chapter 26.1-44, and a new subsection to section 26.1-46-03
- 3 of the North Dakota Century Code, relating to mandatory arbitration endorsements for property
- 4 insurance, managed repair programs, civil remedy actions against property insurers, notice of
- 5 property insurance claims, and surplus lines insurance policies; to amend and reenact sections
- 6 26.1-02-05, 26.1-25-02.1, 26.1-25-16, 26.1-26-04.1, 26.1-44-03, 26.1-46-01, 26.1-46-08, and
- 7 26.1-46-08.1 of the North Dakota Century Code, relating to exceptions to unauthorized
- 8 insurance transactions, exceptions for large commercial risks in fire, property, and casualty
- 9 insurance rates, surplus lines insurance, risk retention groups and purchasing groups,
- 10 restrictions on insurance purchased by purchasing groups, and purchasing group taxation and
- 11 fees; to repeal section 26.1-44-03.3 of the North Dakota Century Code, relating to an exemption
- 12 from search requirements for licensed surplus line producers; to provide for a legislative
- 13 management report; and to provide a penalty.

14 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 15 **SECTION 1. AMENDMENT.** Section 26.1-02-05 of the North Dakota Century Code is
- 16 amended and reenacted as follows:
- 17 **26.1-02-05.** Unauthorized insurance prohibited Exceptions.
- An insurance company may not transact insurance business in this state, as set forth in
- section 26.1-02-06, without a certificate of authority from the commissioner. This section does
- 20 not apply to:
- 21 1. The lawful transaction of surplus lines insurance.
- 22 2. The lawful transaction of reinsurance by insurers.

- Transactions involving a policy lawfully solicited, written, and delivered outside of this state covering only subjects of insurance not resident, located, or expressly to be performed in this state at the time of issuance, and which transactions are subsequent to the issuance of such policy.
 - 4. Transactions involving life insurance, health insurance, or annuities provided to educational or religious or charitable institutions organized and operated without profit to any private shareholder or individual, for the benefit of the institutions and individuals engaged in the service of the institutions.
 - 5. Attorneys acting in the ordinary relation of attorney and client in the adjustment of claims or losses.
 - 6. Transactions involving group life, accident, and health, or blanket accident and health insurance, or group annuities if the master policy of the group was lawfully issued and delivered in and pursuant to the laws of a state in which the insurance company was authorized to do an insurance business, to a group organized for purposes other than the procurement of insurance, and where the policyholder is domiciled or otherwise has a bona fide situs.
 - Transactions involving any insurance policy or annuity contract issued before July 1, 1973.
 - 8. Transactions relative to a policy issued or to be issued outside this state involving insurance on vessels, craft or hulls, cargoes, marine builder's risk, marine protection and indemnity or other risk, including strikes and war risks commonly insured under ocean or wet marine forms of policy.
 - 9. Transactions involving insurance contracts issued to one or more industrial insureds; provided, that this does not relieve an industrial insured from taxation imposed upon independently procured insurance. An industrial insured is an insured:
 - a. Which procures the insurance of any risk or risks other than life and annuity contracts by use of the services of a full-time employee acting as an insurance manager or buyer or the services of a regularly and continuously retained qualified insurance consultant;
 - Whose aggregate annual premiums for insurance on all risks total at least twenty-five thousand dollars; and

- 1 c. Which has at least twenty-five full-time employees.
- 2 <u>10.</u> <u>Transactions involving insurance contracts covering a large commercial risk as</u>
- defined in section 26.1-25-02.1, provided an industrial insured is not relieved from
- 4 <u>taxation imposed upon independently procured insurance.</u>
- 5 **SECTION 2. AMENDMENT.** Section 26.1-25-02.1 of the North Dakota Century Code is amended and reenacted as follows:

7 **26.1-25-02.1.** Definitions.

- 1. "Advisory organization" means any entity, including its affiliates or subsidiaries, which either has two or more member insurers or is controlled either directly or indirectly by two or more insurers, and which assists insurers in ratemaking-related activities as enumerated in this chapter. Two or more insurers having a common ownership or operating in this state under common management or control constitute a single insurer for purposes of this definition.
- 2. "Commercial risk" means any kind of risk which is not a personal risk.
- 15 3. "Competitive market" means a commercial risk market that has not been found to be
 16 noncompetitive as provided for in section 26.1-25-04. All commercial risk markets
 17 except crop hail, farmowners, and medical malpractice insurance are presumed to be
 18 competitive.
 - 4. "Developed losses" means losses including loss adjustment expenses, adjusted, using standard actuarial techniques, to eliminate the effect of differences between current payment or reserve estimates and those needed to provide actual ultimate loss including loss adjustment expense payments.
- 5. "Expenses" means that portion of a rate attributable to acquisition, field supervision, collection expenses, general expenses, taxes, licenses, and fees.
 - 6. "Joint underwriting" means a voluntary arrangement established to provide insurance coverage for a commercial risk pursuant to which two or more insurers jointly contract with the insured at a price and under policy terms agreed upon between the insurers.
- 7. "Large commercial risk" means an insured that has:
 - a. Total insured property values of twenty-five million dollars or more;
 - b. Total annual gross revenue of fifty million dollars or more; or

1		c. A total premium of one hundred thousand dollars or more for property insurance					
2		one hundred thousand dollars or more for general liability insurance, or					
3		two hundred thousand dollars or more for multiperil insurance.					
4		d. The term does not include farming or ranching.					
5	<u>8.</u>	"Loss trending" means any procedure for projecting developed losses to the average					
6		date of loss for the period during which the policies are to be effective.					
7	8. 9.	"Noncompetitive market" means the crop hail, farmowners, and medical malpractice					
8		insurance markets together with any other line of commercial risk insurance that has					
9		not been found by the commissioner to have a reasonable degree of competitiveness					
10		within the market considering:					
11		a. Market concentration and changes in market concentration determined through					
12		the use of the Herfindahl-Hirschman index and the United States department of					
13		justice merger guidelines for an unconcentrated market;					
14		b. The existence of financial and other barriers that prevent a company from					
15		entering the market;					
16		c. The number of insurers or groups of affiliated insurers providing coverage in the					
17		market;					
18		d. The extent to which any insurer or group of affiliated insurers controls the market					
19		e. Whether the total number of companies writing the line of insurance in this state					
20		is sufficient to provide multiple insurance options in the market;					
21		f. The availability of insurance coverage to consumers in the markets by specific					
22		geographic area, by line of insurance, and by class of risk; and					
23		g. The opportunities available in the market to acquire pricing and other consumer					
24		information.					
25		A determination that a market is noncompetitive may not be based solely on the					
26		consideration of any one factor.					
27	9. 10.	"Personal risk" means homeowners, tenants, private passenger nonfleet automobiles					
28		mobile homes, and other property and casualty insurance for personal, family, or					
29		household needs.					
30	10. <u>11.</u>	"Pool" means a voluntary arrangement, established on an ongoing basis, pursuant to					
31		which two or more insurers participate in the sharing of risks on a predetermined					

1 basis. The pool may operate through an association, syndicate, or other pooling 2 agreement. 3 11.12. "Prospective loss costs" means that portion of a rate that does not include provisions 4 for expenses other than loss adjustment expenses, or profit, and are based on 5 historical aggregate losses and loss adjustment expenses adjusted through 6 development to their ultimate value and projected through trending to a future point in 7 time. 8 12.13. "Rate" means that cost of insurance per exposure unit whether expressed as a single 9 member or as a prospective loss cost with an adjustment to account for the treatment 10 of expenses, profit, and individual insurer variation in loss experience, prior to any 11 application of individual risk variations based on loss or expense considerations, and 12 does not include minimum premium. 13 13.14. "Residual market mechanism" means an arrangement, either voluntary or mandated 14 by law, involving participation by insurers in the equitable apportionment among them 15 of insurance which may be afforded applicants who are unable to obtain insurance 16 through ordinary methods. 17 14.15. "Supplementary rating information" includes any manual or plan of rates, classification, 18 rating schedule, minimum premium, policy fee, rating rule, underwriting rule, statistical 19 plan, and any other similar information needed to determine the applicable rate in 20 effect or to be in effect. 21 15.16. "Supporting information" means: 22 The experience and judgment of the filer and the experience or date of other a. 23 insurers or advisory organizations relied upon by the filer; 24 b. The interpretation of any other data relied upon by the filer; and 25 C. Descriptions of methods used in making the rates and any other information 26 required by the commissioner to be filed. 27 SECTION 3. AMENDMENT. Section 26.1-25-16 of the North Dakota Century Code is 28 amended and reenacted as follows: 29 26.1-25-16. Rebates prohibited - Exception. 30 1. No insurance producer May not knowingly charge, demand, or 31 receive a premium for any insurance policy except in accordance with this chapter. No

insurer or employee of an insurer, and no insurance producer, broker or agent may pay, allow, or give, or offer to pay, allow, or give, directly or indirectly, as an inducement to insurance, or after insurance has been effected, any rebate, discount, abatement, credit, or reduction of the premium named in an insurance policy, or any special favor or advantage in the dividends or other benefits to accrue on the policy, or any valuable consideration or inducement whatever, not specified in the insurance policy, except to the extent provided for in applicable filing. No insured named in an insurance policy, nor any employee of the insured, may knowingly receive or accept, directly or indirectly, any such rebate, discount, abatement, credit, or reduction of premium, or any such special favor or advantage or valuable consideration or inducement. This section does not prohibit the payment of commissions or other compensation to licensed insurance producers, nor any insurer from allowing or returning to its participating policyholders, members, or subscribers dividends, savings, or unabsorbed premium deposits. As used in this section, "insurance" includes suretyship and "policy" includes bond and federal crop insurance.

2. Notwithstanding any other provision in this section, if the cost does not exceed an aggregate retail value of one hundred dollars per person per year, an insurance producer may give a gift, prize, promotional article, logo merchandise, meal, or entertainment activity directly or indirectly to a person in connection with marketing, promoting, or advertising the business. As used in this subsection, "person" means the named insured, policy owner, or prospective client or the spouse of any of these individuals, but the term does not include a certificate holder, child, or employee of the named insured, policy owner, or prospective client. Subject to the limits of this subsection, an insurance producer may give a gift card for specific merchandise or services such as a meal, gasoline, or car wash but may not give cash, a cash card, any form of currency, or any refund or discount in premium. An insurance producer may not condition the giving of a gift, prize, promotional article, logo merchandise, meal, or entertainment activity on obtaining a quote or a contract of insurance. Notwithstanding the limitation in this subsection, an insurance producer may conduct raffles or drawings, if there is no financial cost to an entrant to participate, the drawing or raffle does not obligate a participant to purchase insurance, the prizes are not

1 valued in excess of a reasonable amount determined by the commissioner, and the 2 drawing or raffle is open to the public. The raffle or drawing must be offered in a 3 manner that is not unfairly discriminatory and may not be contingent on the purchase, 4 continued purchase, or renewal of a policy. Notwithstanding the limitation in this 5 subsection, an insurance producer may make a donation to a nonprofit organization 6 that is exempt from federal taxation under Internal Revenue Code section 501(c)(3) 7 [26 U.S.C. 501(c)(3)] in any amount as long as the donation is not given as an 8 inducement to obtain a contract of insurance. 9 3. The provisions in this section may not be construed as including within the definition of 10 discrimination or rebates any of the following practices: 11 The offer or provision by an insurer or producer, by or through an employee, an 12 affiliate, or a third-party representative, of value-added products or services at no 13 or reduced cost if the products or services are not specified in the policy of 14 insurance if the product or service: 15 Relates to the insurance coverage and is designed to satisfy one or more of 16 the following: 17 (a) Provide loss mitigation or loss control; 18 (b) Reduce claims costs or claim settlement costs; 19 (c) Provide education about liability risk or risk of loss to persons or 20 property; 21 (d) Monitor or assess risk, identify sources of risk, or develop strategies 22 for eliminating or reducing risk; 23 (e) Enhance health; 24 (f) Enhance financial wellness through items such as education of 25 financial planning services; 26 Provide post-loss services; (g) 27 (h) Incent behavioral changes to improve the health or reduce the risk of 28 death or disability of an individual defined as policyholder, potential 29 policyholder, certificate holder, potential certificate holder, insured, 30 potential insured, or applicant; or

2			insurance coverage.
3		(2)	If offered by the insurer or producer, the insurer or producer, upon request,
4			shall ensure the person is provided with contact information to assist the
5			person with questions regarding the product or service.
6		(3)	Is based on fair documented criteria and offered in a manner not unfairly
7			discriminatory. The documented criteria must be maintained by the insurer
8			or producer and produced at the request of the commissioner.
9		(4)	Is reasonable in comparison to that person's premiums or insurance
10			coverage for the policy class.

Before rendering the services and accepting any payment, a written disclosure 4 must be provided to the party to be charged on a form approved by the 5 commissioner disclosing: 6 (1) The nature of the services for which the fees will be charged along with a 7 separate itemization of the amount of the fees; 8 (2) That the fees are charged in addition to any premiums paid; 9 (3) That if the insurance producer is also an appointed agent of an insurer with 10 which coverage is being considered for placement, a statement that the 11 insurance producer also represents the insurer in the transaction and owes 12 a duty of loyalty to the insurer; and 13 That if the insurance producer is to receive a commission from the sale of 14 an insurance policy related to the services rendered, a statement clearly 15 and completely disclosing that the: 16 Insurance producer will receive a commission from the insurer which (a) 17 is paid from the premiums owed for the insurance; and 18 (b) Amount of commission received by the insurance producer may differ 19 depending on the product sold and the insurer. 20 The disclosure required by this section must be signed and dated by both the C. 21 producer and the party to be charged. 22 The producer shall retain the signed disclosure required by this section for not d. 23 less than five years following the completion of the service. A copy of the signed 24 disclosure must be available to the commissioner for inspection upon request. 25 The insurance producer may not pay or return, or offer to pay or return, all or part e. 26 of a fee charged as an inducement to purchase a specific policy, or coverage 27 within a policy, or coverage from a particular insurer. 28 Any fee charged under this section must bear a reasonable relationship to the 29 services provided and may not be discriminatory. 30 2. An insurance producer charging a fee for services rendered for risk management

services under this section owes the person to be charged a higher standard of care

A purchasing group which obtains liability insurance from an insurer not admitted in this state or a risk retention group shall inform each of the members of the group which have a risk resident or located in this state that the risk is not protected by an insurance insolvency guaranty fund in this state, and that the risk retention group or insurer may not be subject to all insurance laws and rules of this state.
- 3. NoA purchasing group may not purchase insurance providing for a deductible or self-insured retention applicable to the group as a whole; however, coverage may provide for a deductible or self-insured retention applicable to individual members unless the purchasing group uses a policyholder's disclosure statement approved by the commissioner which clearly explains in simplified language the policy is subject to a group deductible or self-insured retention and provides a detailed explanation of the process of the satisfaction of the deductible or self-insured retention among members.
- 4. Purchases of insurance by purchasing groups are subject to the same standards regarding aggregate limits which are applicable to all purchases of group insurance. A purchasing group may not purchase insurance providing for a shared aggregate limit applicable to the group as a whole unless the purchasing group uses a policyholder's disclosure statement approved by the commissioner which clearly explains in

1	simplified language the policy is subject to a group aggregate limit and coverage for

1 SECTION 16. INSURANCE COMMISSIONER STUDY - TOWING AND RECOVERY 2 **COVERAGE FOR VEHICLES WITH LIABILITY-ONLY INSURANCE - REPORT TO** 3 LEGISLATIVE MANAGEMENT. 4 1. During the 2025-26 interim, the insurance commissioner may study the feasibility, 5 benefits, and challenges of providing towing and recovery costs associated with 6 vehicle liability-only insurance for towing operations. The study must be conducted 7 with stakeholders from both the insurance industry and the towing industry. The study 8 must include: 9 An evaluation of the frequency and financial impact of the towing and recovery 10 costs of vehicles without applicable insurance coverage. 11 A review of the cost structures, fee practices, and reimbursement models b. 12 associated with standard towing and recovery operations across this state. 13 Consideration of the financial and operational implications of expanding coverage 14 to include towing and recovery cost coverage for the at-fault vehicle with only 15 liability coverage. 16 An analysis of the regulatory, administrative, and consumer impacts resulting d. 17 from the coverage expansion, including anticipated efficiencies or burdens. 18 e. A review of approaches taken by other states regarding similar coverage options, 19 including statutory or regulatory frameworks, and how those states balance the 20 needs of insurers, towing providers, and consumers. 21 An analysis of insurance protocols and preferred procedures regarding towing 22 operations. For the purpose of establishing agreements and contracts between 23 insurance companies and towing companies, preventing misunderstandings, and 24 ensuring a seamless claims process. 25 2. Before September 1, 2026, the insurance commissioner shall report its findings and 26 recommendations, together with any legislation required to implement the

recommendations, to the legislative management.
