

**SECOND ENGROSSMENT**

**REENGROSSED SENATE BILL NO. 2376**

1 A BILL for an Act to amend and reenact subsection 5 of section 54-58-03 of the North Dakota  
2 Century Code, relating to a tribal-state gaming compact that permits gaming in Grand Forks  
3 County.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 5 of section 54-58-03 of the North Dakota Century  
6 Code is amended and reenacted as follows:

7 5. The compact may not authorize gaming to be conducted by an Indian tribe at any  
8 off-reservation location not permitted under a tribal-state gaming compact in effect on  
9 August 1, 1997, except that in the case of the tribal-state gaming compact between  
10 the Turtle Mountain Band of Chippewa and the state, gaming may be conducted on  
11 land within Rolette County held in trust for the Band by the United States government  
12 which was in trust as of the effective date of the Indian Gaming Regulatory Act of 1988  
13 [Pub. L. 100-497; 102 Stat. 2467; 25 U.S.C. 2701 et seq.] and on the following  
14 described real property situated within Grand Forks County, North Dakota, if approved  
15 by the secretary of the interior under the Indian Gaming Regulatory Act of 1988  
16 [Pub. L. 100-497; 102 Stat. 2467; 25 U.S.C. 2701 et seq.]:

17 a. The south five and one-half acres of the east sixty-four acres of the northeast  
18 quarter, section thirty, township one hundred fifty-one, range fifty;

19 b. The west ninety-six acres of the northeast quarter of section thirty, township  
20 one hundred fifty-one, range fifty; and

21 c. The north fifty-eight and one-half acres of the east sixty-four acres of the  
22 northeast quarter of section thirty, township one hundred fifty-one, range fifty.

1                   except the north seven hundred ten and seventy-seven one-hundredths feet of  
2                   the east six hundred forty-three and one-half feet thereof and except that part of  
3                   the northeast quarter of the northeast quarter of section thirty, township  
4                   one hundred fifty-one, range fifty west of the fifth principal meridian, described as  
5                   follows: beginning at the northeast corner of section thirty; thence south zero  
6                   degrees zero minutes zero seconds west, assumed bearing, along the east line  
7                   of section thirty a distance of eight hundred and sixty and seventy-seven  
8                   one-hundredths feet; thence south eighty-nine degrees thirty-six minutes zero  
9                   seconds west seven hundred and three and one-half feet; thence north zero  
10                  degrees zero minutes zero seconds east eight hundred and sixty and seventy-  
11                  seven one-hundredths feet to the north line of section thirty; thence north  
12                  eighty-nine degrees thirty-six minutes zero seconds east, along the north line of  
13                  said section thirty, a distance of seven hundred and three and one-half feet to the  
14                  point of beginning.
