HB 1130 adds the building fund levy to the sinking and interest fund levy to calculate the in lieu of property tax deduction in the Integrated Formula Payment.

HB 1130 changes the in lieu of property tax calculation from using the sinking and interest levy divided by the total levy to the building fund levy plus the sinking and interest levy divided by the total levy before the 75% deduction in the integrated formula payment. School districts would be required to use the additional funds that are not factored into the integrated formula payment towards the school districts' sinking and interest fund and applied for debt repayment.
