HB1098 establishes eligibility criteria for the North Dakota Scholarship for students pursuing a teaching career. This bill includes additional eligibility criteria that expands the number of students eligible for the North Dakota Scholarship.

Section 1 expands eligibility to receive a North Dakota Scholarship, this bill adds section (c) under subsection 6. b(1) as follows: Two units of career and technical education can consist of [1] One unit of teaching profession education or educational

methodology; and

[2] One unit of advanced placement psychology, dual - credit psychology, child development, peer - to - peer leadership, child related careers, or any combination thereof;

Based on data from the graduating classes of 2022, 2023, and 2024, it is estimated that HB 1098 would result in 9 additional scholarships being awarded for each graduating class. When calculating the next several school year's fiscal impact and assuming \$1500 per school year per student, the fiscal impact would be:

- 2023-2025 Biennium: \$0.00
- 2025-2027 Biennium: \$40,500 (1 class of 9 students for 2025-2026, 2 classes of 9 students for 2026-2027)
- 2027-2029 Biennium: \$94,500. (3 classes of 9 students for 2027-2028, 4 classes of 9 students for 2028-2029)
- 2029-2031 Biennium and beyond: \$108,000 per biennium (4 classes of 9 students each school year)
