SB 2231 adds coverage of medically necessary dental services for individuals eligible under Medicaid Expansion. The services would be carved out from managed care and managed by the department.

Section 1 of SB 2231 requires the Department to cover dental services for individuals covered by Medicaid Expansion. The Department estimates the cost of providing these services is \$3,426,269 annually. The services would be carved out from managed care and covered under the current Medicaid Fee Schedule. The coverage would start January 1, 2026 and would include 18 months of costs, or \$5,139,404.

The coverage would start January 1, 2026 and the fiscal impact includes 18 months of costs.

The total projected costs related to SB 2231 for the 2025-27 biennium are as follows; Grants - Medical Assistance of \$5,139,404 of which, \$516,940 is General Fund.
