This bill would allow a motor vehicle owner to request only one license plate upon payment of an additional fee.

This bill would charge an additional fee of \$125 for only one license plate.

## 5 - Revenues Detail

The total number of qualifying vehicles would be 760,967, including an estimated 16,000 higher-end and sport vehicles. It is estimated that 1% of the overall vehicles would participate and 50% of the higher-end vehicles, generating \$1,931,209 the first year. Additionally, each year Motor Vehicle averages 220,000 title transfers per year. Motor Vehicle estimates 1% would request one plate generating an additional \$275,000 each additional year.

This revenue would increase the distribution through the Highway Tax Distribution Fund as Motor Vehicle costs are funded off the top of the Highway Tax Distribution Fund. The impact to counties is (22%), cities (12.5%), townships (2.7%), public transit (1.5%), and the State Highway Fund (61.3%).

NDDOT does not have a way to determine the amount of revenue generated from fees for violation of 39-04-11.
