North Dakota Century Code Section 44-08-04 provides for meal reimbursements for state officers and employees while traveling in the state as follows:

• First quarter (6:00 a.m. to 12:00 noon) - \$ 9.00

- Second quarter (12:00 noon to 6:00 p.m.) \$14.00
- Third quarter (6:00 p.m. to 12:00 midnight) \$22.00

For the 2025 and 2027 legislative sessions, the Legislative Council has budgeted 77 legislative days for eacg regular session and 3 days for each organizational session. Including travel days during session, the estimated cost of providing meal reimbursements to members of the Legislative Assembly during the 2023-25 biennium (2025 legislative session) is \$482,625. The estimated cost for the 2025-27 biennium (2027 legislative session) is \$502,250. The estimated cost for the 2027-29 biennium (2029 legislative session) is also \$502,250. The 2023-25 biennium costs are less because the bill is retroactive to January 2025; therefore, legislators would not receive meal reimbursement for the December 2024 organizational session.
