We estimated the cost of becoming certified in CPR at \$35 per individual. There are currently 34,816 students in grades 9-12 in North Dakota. If each of these students became certified in CPR once every two years (CPR typically expires every two years), that would come to a cost of \$1,218,560 per biennium. This number could potentially be significantly lower, however, if not all students choose to become certified or if schools are able to offer the certification in a course that it already being taught.
