HB 1525 moves the administration and regulation of gaming and lottery from the Attorney General; the administration of combative sports from the Secretary of State; and the administration of pari-mutuel racing from the Racing Commission to a Gaming Commission.

### 4 - Fiscal Impact Sections Detail

The cost of establishing a gaming commission to complete the duties currently being performed by the Attorney General, the Secretary of State, and the Racing Commission cannot be determined. Areas of consideration would include:

· the cost of a location for gaming commission staff;

- the cost of completing and maintaining the gaming information system;
- the cost of a new location for the lottery division, or the renegotiation of a new lease in the current location;
- the cost of moving and maintaining the lottery division systems;
- fees collected by the Secretary of State for combative sports do not offset the cost of maintaining the program, the Secretary of State subsidizes the program from \$30,000 to \$50,000 per biennium, depending on how many events are scheduled; and
- it appears the Racing Commission would be eliminated as a state agency with the duties assumed by the executive director of the new gaming commission.

#### 5 - Revenues Detail

The bill eliminates the quarterly transfer of lottery funds to the Multijurisdictional Drug Task Force Grant Fund resulting in a loss of \$2 million per biennium for the statewide drug task forces. Since we are unable to determine what the cost of a new gaming commission would be, it is unclear whether this would be an equal increase in the general fund transfer of lottery funds or if it would be less.

Several staff of the Office provide administrative assistance to the Gaming and Lottery divisions. The cost of this is allocated to the gaming and lottery funds. While the staff time will be filled with other Office duties, the biennial allocations will need to be replaced by the general fund - \$697,000. In addition, the loss of Lottery rent and utilities will need to be replaced by the general fund - \$130,660.
