SB 2241 allows for public charter schools and calculates the state aid for approved charter schools.

### 4 - Fiscal Impact Sections Detail

The fiscal impact for SB 2241 cannot be determined. This bill allows for public charter schools to approved by the Superintendent of Public Instruction. Public charter schools generate state funding using the per-pupil state aid payment. (2024-2025 is \$11,072) If students enroll in a public charter school that were previously educated in a North Dakota public school, there would be a savings to the state. On average, a student enrolled in a public school will generate 1.20 weighted student units. Each student that enrolls in a public charter school from a public school would save the state approximately \$2200 per student. This savings will vary on the size of the school district that

the student enrolls from.

If students enrolled in charter schools from private school or home school, there is an increased cost to the state of \$11,072 per student. Admin rules cost the department approximately \$2500.
