SB2142 as amended states in Section 1 to transfer all revenues collected for motor vehicle excise tax to be 100% to the Flexible Transportation Fund.

SB2142 as amended states in Section 1 to transfer all revenues collected for motor vehicle excise tax to be 100% to the Flexible Transportation Fund which amends NDCC 57-40.3-10. Currently, NDCC 57-40.3-10 states 50% must be deposited to the general fund and 50% must be deposited to the Flexible Transportation Fund. The amended language would eliminate the deposit to the General Fund, deposit 100% to the Flexible Transportation Fund.
