The bill amendment increases hunting license fees and fishing license fees for ND Game and Fish.

The last license fee increase occurred in the 2013 Legislative Session. The new fees began in April of 2014 to align with the season license structure. The Game and Fish operating fund balance has been declining annually and is projected to reach \$12.9 million by 6/30/27. According to NDCC 20.1-02-16.1, the game and fish fund balance cannot drop below \$15 million without budget section approval. License fee adjustments would help address this fund balance.
