This bill changes the registration weight of a pickup truck from twice the shipping weight to the Gross Vehicle Weight Rating.

Section 1 of the bill changes the registration weight of a pickup truck from twice the shipping weight to the Gross Vehicle Weight Rating. This would result in an estimated revenue reduction of \$40 per registered pickup truck.

In 2024 Motor Vehicle registered 278,179 pickup trucks. We estimate a \$40 revenue decrease on each registration based the most popular registered pickup trucks in North Dakota. We estimate the number of pickup trucks registered will increase 2% starting with fiscal year 2025.

For the 2025-2027 biennium MV estimates a total decrease in revenue by \$22,926,400. For the 2027-2029 biennium MV estimates a total decrease in revenue by \$23,852,627. This revenue would decrease the distribution through the Highway Tax Distribution Fund. The impact to counties is (22%), cities (12.5%), townships (2.7%), public transit (1.5%), and the State Highway Fund (61.3%) would be applied to the biennial reduction of revenue for the Highway Tax Distribution Fund.
