HB 1344 will have minimal fiscal impact to the DOCR. DOCR implemented its prison population management plan to prioritize admissions in accordance with NDCC 54-23.3-11 including compensation to the jails or correctional facilities.

HB 1344 will have minimal fiscal impact to the DOCR. In October 2024 the DOCR implemented its prison population management plan to prioritize admissions in accordance with NDCC 54-23.3-11 including compensation to the jails or correctional facilities. In October 2024 the DOCR compensated counties around \$50,000 for a small number of inmates who were delayed admission. We do not anticipate this will continue and we will implement prioritization

plan for female inmates.

We anticipate, based on inmate population forecast, that we will not see a decrease in our inmate population during the upcoming biennium and we will remain in prioritization with our male population. We currently exceed the budgeted capacity for female population but have not implemented our prioritization plan for females and have been collaborating with county jails and corrections facilities to avoid implementing prioritization for females. HB1344 may require that we now implement prioritization to address the female population. The DOCR has included deferred admissions compensation relating to NDCC 54-23.3-11 for the county jails and correctional facilities in our budget for 2025-2027.

The DOCR does not project any revenues from this bill. There will be revenues for county and jail facilities receiving compensation for housing of inmates deferred from admission.
