HB 1565 calls for NDDPI to provide grants to tribally controlled schools for nonbeneficiary students that attend their schools.

Section 1 of the bill (page 1, lines 7-17) calls for NDDPI to provide grants to tribally controlled schools for nonbeneficiary students that attend their schools.

There are no revenues in HB 1565.

Because the bill does not specify the amount of the grant, we used the current per pupil payment amount of \$11,072 as the amount to calculate the fiscal note. To determine the amount of nonbeneficiary students that would generate a grant, we contacted the tribally controlled schools that this would impact and asked them to provide us with the number of nonbeneficiary students attended their schools. Based on the responses that we received, we estimate that there are approximately 77 nonbeneficiary students attending tribally controlled schools in North Dakota (we do want to emphasize that this student number is only an estimate). at a rate of \$11,072 per student, that dollar amount for the grants comes to \$852,544 per year, or \$1,705,088 per biennium. Please also note that the per pupil funding amount may change, pending the result of HB 1369.
