SB 1464 would create a mechanism for certifying postpartum doulas and Medicaid reimbursement for their services.

SB 1464 would create a mechanism for certifying postpartum doulas and Medicaid reimbursement for their services.

Subsection 1 of Section 2 creates Medicaid reimbursement for postpartum doula services. The fiscal impact is for Medicaid payments to certified postpartum doulas, beginning in the second year of the 2025-2027 biennium. We estimate that 30 providers will deliver three one-hour visits per week. The estimated cost for the service delivery for the 2025-2027 biennium is \$280,800.

Year 1: We estimate 30 providers will deliver three one-hour visits per week for 90 visits per week. The cost of delivering a one-hour visit is billed at \$15 per 15-minute interval. The estimated cost for the service delivery for the 2025-2027 biennium is \$280,800.

The total projected costs related to SB 1464 for the 2025-2027 biennium are as follows;
Grants - Medical Assistance is \$280,800 of which, 137,620 is General.
