HB 1399 increases the amount for which counties can request reimbursements for prosecution witness fees and expenses from \$25,000 per county to \$30,000 per county. Counties that exceed the \$30,000 limit may enter into an agreement with another county to use their unused limit.

The bill would allow counties to reach agreements with other counties to use uncommitted funds.

An increase of \$5,000 per county is \$265,000. The Office of Attorney General would need the full amount added to cover any agreements made between counties to use uncommitted funds.

During the 2021-23 biennium, total reimbursement claims totaled \$146,648 which is \$51,648 more than the \$95,000 budgeted for reimbursements. Three counties met their \$25,000 limit in 2021-23.

For the 2023-25 biennium, through December 2024, reimbursements to counties totaled \$84,748. One county has requested over \$20,000, one county has requested over \$16,00, and two counties have requested over \$10,000.
