Retirement and Investment Office, together with its consulting agency, RVK has reviewed the legislation proposed in this bill. With our initial analysis we would expect the passage of this bill to have little to no financial impact on the legacy fund.

Natural Asset Companies (“NACs”) were developed by the New York Stock Exchange (“NYSE”) with the Intrinsic Exchange Group to allow investors to invest financial capital into the services that directly benefit the plant through the preservation of nature and ecosystems.

They do not appear to be organized for the primary purpose of generating a financial return, and as such would likely already be prohibited from investment in North Dakota under the Prudent Investor Rule. Although the NYSE had plans to list NACs as tradable assets, they withdrew their plans to do so in January of 2024.
