SUMMARY OF ACTUARIAL INFORMATION

BILL NO: Engrossed HB 1423

BILL DESCRIPTION: Remodeling and Vehicle/Vehicle Adaptation Expense

SUMMARY OF ACTUARIAL INFORMATION: Workforce Safety & Insurance, together with its consulting actuaries, The Burkhalter Group, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The amended legislation:

- Increases the lifetime cap for remodeling expenses for the catastrophically injured from \$75,000 to \$150,000;
- Increases the lifetime cap for vehicles and vehicle adaptation expenses for the catastrophically injured from \$150,000 to \$200,000; and
- Establishes an annual escalator for these caps based on the Consumer Price Index.

FISCAL IMPACT:

The proposed legislation will increase benefit costs for a small subset of claims with catastrophic injuries; however, we don't anticipate the legislation having a material impact on statewide rate and reserve levels.
