HB 1521 modifies the motor vehicle excise tax exemption for enrolled tribal members.

If enacted, section 1 of HB 1521 would provide an exemption for motor vehicle excise tax on motor vehicles acquired at any location within this state by an individual who is an enrolled member of a federally recognized Indian tribe within this state, regardless of the location of the individual's primary residence.

The fiscal impact based on 992 sales annually to tribal members residing outside the exterior boundaries of an Indian Reservation in the state, by eliminating the 5 percent vehicle excise tax from those purchases, applied to an annual sales figure of \$35,444,934, is \$1,772,247 annually or \$3,544,494 per biennium.
